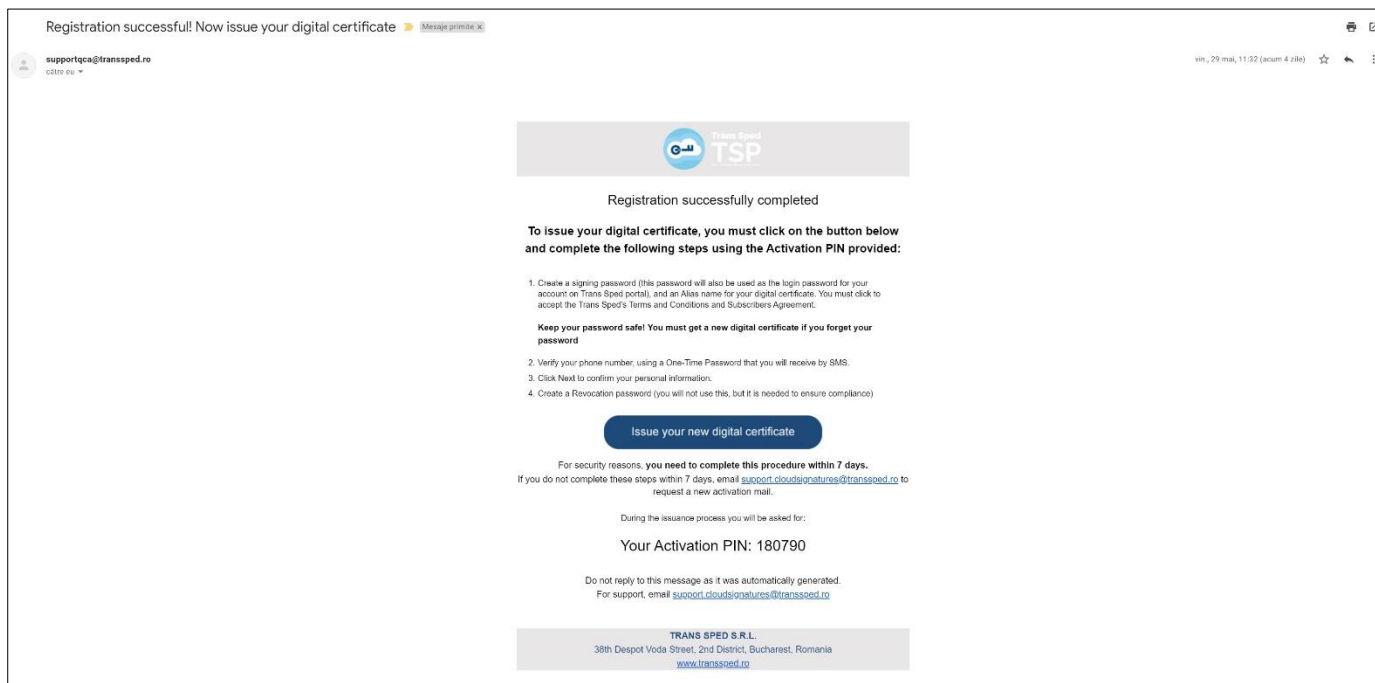

1. Introduction

This guide describes the steps for activating a cloud qualified digital certificate issued by Trans Sped.

2. Activating cloud qualified digital certificate


After Trans Sped representatives have verified the documents and issued the Qualified Certificate, you will receive an email on the email address entered on the form that will include the following data:



Follow the steps below to activate your cloud qualified digital certificate.


Step 1. Click on [here](#) where you will enter the phone number declared at the enrollment of the certificate and the activation PIN, received via SMS.

NOTE! THE PHONE NUMBER MUST CONTAIN THE COUNTRY PREFIX.





- *Alias (Your chosen name to be used to upload the certificate to your local computer)*

After filling the fields, the two documents **Terms and Conditions** and the **User Agreement** will be displayed, be readed carefully, after which the two boxes will be ticked to express their agreement, and **Next** button will be pressed.

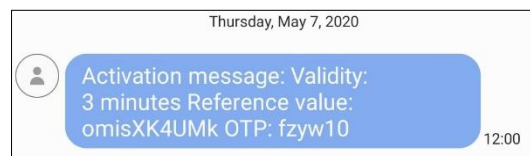

Step.4. After completing the certificate issuance data, a new window will be displayed where you will enter the **Tancode** code received by SMS on the number stated on the certificate.

The message will have the following form:

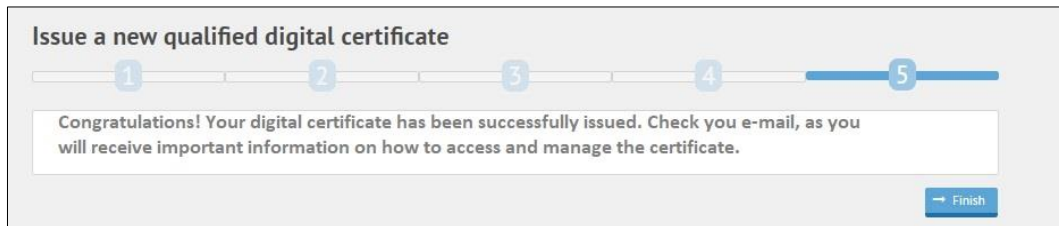

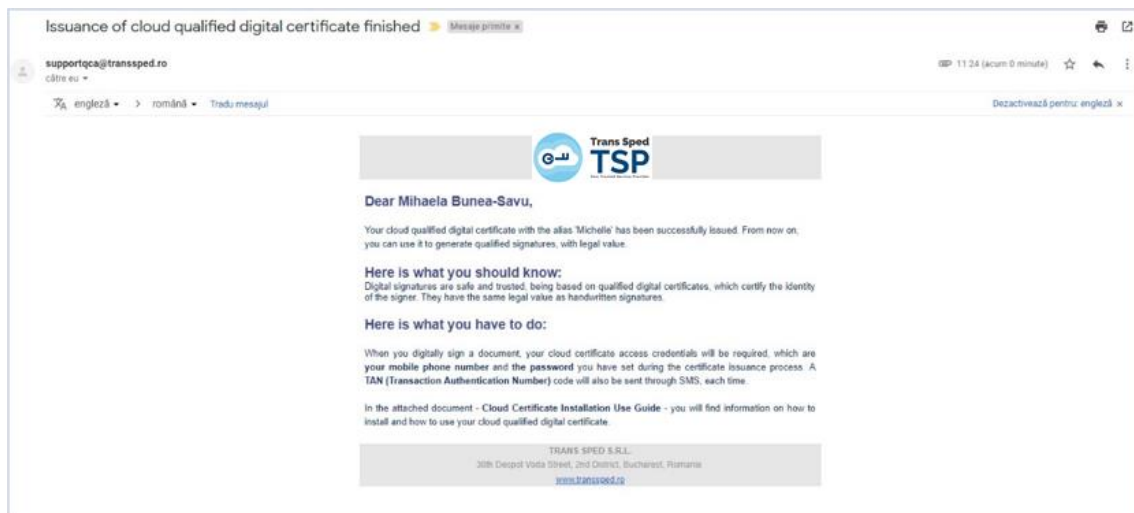
